AGENDA ITEM #3 – OLD BUSINESS

- **3.1 Tri-County Institute** The annual Tri-County Institute took place at Centralia High School on Friday, February 17, 2017, from 8:10 a.m. 2:00 p.m. The first session began at 8:10 a.m., and there was a total of six sessions offered to teachers and administrators. According to feedback from our teachers, the workshops they attended were very advantageous.
- **3.2 Final Results of Basketball Season** Our varsity basketball team had a much better season than their record reflects, as they played very competitively throughout its entirety. In the regional play, we were ousted in the first round when defeated by a tough Rome Grade School team. North Wamac's final record was 10-16. The junior varsity record currently stands at 9-9, and they continue to play in the Central City 7th Grade Invitational Tournament, which began Tuesday evening.
- **3.3 Volleyball Team Status** The volleyball team has begun the season in an impressive fashion. Our varsity team is currently 5-2, and our junior varsity team is 7-0. The teams have three games this week, as well as the St. Theresa Invitational Tournament on Saturday.

- **3.4 FY17 School Calendar** If the current weather is indicative of the remainder of the winter season, Mr. Morris believes we should have no worries about any additional weather-related school closings. As a result, North Wamac School's last projected day of student attendance will be Wednesday, May 24, 2017.
- **3.5 HVAC Replacement** As mentioned at the January school board meeting, the air conditioning units that cool Mrs. Neudecker's, Mrs. Squibb's, and Ms. Wood's classrooms quit working quite some time ago; but, it was right before the cooler fall temperatures began, so the repair was not a high-priority item at that time. Since spring is approaching along with increased temperatures, McDonnough Heating & Air will install the new units in the near future.

- **4.5 School Safety Emergency Response Team** Mr. Morris is in the process of looking into tying the school's fire and security alarm systems into our key fob (entry) and surveillance systems. Currently, we are operating the fire and security alarm systems with one company and the key fob and surveillance systems with another. Combining all functions with just one company will simplify our emergency drill and emergency processes and, most importantly, make those processes more efficient.
