7.2 Field Trip to Busch Stadium - Mr. Morris stated that on Wednesday, April 19th, students in grades 5-8 would attend a St. Louis Cardinals' baseball game in St. Louis. The game begins at 12:45. Prior to the game, the students would enjoy a "Weather Day" presentation.

7.3 Faculty/Staff Appreciation Week - Mr. Morris stated that the week of May 8th - 12th has been dedicated as "Teacher/Staff Appreciation Week". Throughout the week, faculty and staff will receive special gifts and luncheons to show appreciation for their quality service.

7.4 8th Grade Diplomas - We have received the 8th grade diplomas for our 2023 graduates. Our school board president, Norman Faulkner, will need to sign those diplomas.

7.5 End of Year Activities - Mr. Morris stated that we have a few track meets to finish out the year but also planned are Cedarhurst presentations, Athletic Awards, 8th grade trip to Holiday World, and a Play Day for the students on the 25th of May. 7.8 Student Handbook Policies - The faculty are reviewing the "Student Handbook" policies for the 2023-2024 school year. Mr. Morris will have any recommended changes at the May board meeting.

7.9 Appointment of KSED Governing Board Member for the 2023-2024 school year -Mr. Morris stated that we need to appoint one of our board members to serve as the NW representative for the KSED Governing Board. There are 2 meetings per year.

7.10 KSED Fall Governing Board Meeting - Kerri Hawley stated that the fall meeting will be held on August 28th and it will be "in person" instead of virtually.

7.11 Potential Secretarial Position - Mr. Morris stated that he would like to explore the possibility of hiring a secretary for the 2023/2024 school year. The position would be for approximately 25-35 hours per week over a 10 month period. Benefits would include 10 sick days and IMRF. There would be no health insurance option.

7.12 Teachers' Rep (Megan Marcum) - Mrs. Marcum stated she is facing a struggle on how to teach our new Spanish-speaking student in 2nd grade. She has adapted many different methods including translating airpods as well as the Rosetta Stone program and flashcards. The most beneficial method so far has been having a fellow student in 2nd grade as a translator. She has helped so much and recommends an appreciation gift for her at the end of the school year.
